Switch to IBM Sub-capacity Licensing to significantly reduce costs

IBM Sub-capacity Licensing is a fantastic way for you to take advantage of cheaper licensing for your IT infrastructure.

By licensing only the activated cores within a virtual environment, significant cost savings are possible. In order to take advantage of this, you are required to use the IBM License Metric Tool (ILMT) to measure and report against the Processor Value Units (PVU's) and Resource Value Units (RVUs) being consumed by the IBM products.

Whether you wish to take advantage of sub capacity licensing, or are concerned that you may not be following the sub capacity terms and conditions - Bytes can provide you with the necessary services to assist.

Already operating on a Sub-capacity?

There could be a significant financial risk to your business if you don't have the required controls and ILMT deployment in place. In this scenario, IBM would be able to enforce that the underlying infrastructure is licensed in full, the cost implications of which could potentially be substantial.

Common challenges to sub-capacity licensing

- IBM enforces a strict policy regarding licensing and requires that you must have Passport Advantage and deploy either ILMT or Tivoli Asset Discovery for Distributed ("TAD4D") in order to qualify for a sub-capacity licence. Moreover, it must be the latest version or, in extenuating circumstances such as non-compatibility, a suitable product instead
- Failure to maintain quarterly reports from ILMT can result in IBM enforcing full capacity licensing calculations and commencing a compliance audit and potentially, greater costs for you
- When licensing full-capacity products on servers within a cluster (where movement is in place), the most powerful server with the highest PVU metric must be used. This is known as the "highest watermark" in the cluster
- Customers must review and maintain the configuration of their estate within ILMT to ensure metrics are being properly recorded and they are not reporting out-of-scope servers or over reporting/ double counting product installations

Sub-capacity Licensing gives the customer significant savings on their IBM eligible products compared to full capacity licensing, as long as the correct virtualisation technologies are used.

In order to use Sub-capacity Licensing customers must:


- **use eligible Sub-capacity products**
- **use qualified virtualisation technologies**
- **use appropriate processor technologies**
- **use a permitted license metric tool e.g. ILMT**

Sub-capacity versus full capacity licensing could result in over £1 Million worth of savings!



Licensing on a POWER 595 server with 64 cores at Full Capacity would cost 64 x 120 (PVU Core Value) = 7680 PVUs. With pricing at c. £160 per PVU this would cost over £1.2M.

With the same server running a virtual instance with 4 Cores assigned and the obligations of Sub-capacity Licensing being met, the pricing would be 4 x 120 = 480 PVUs. Using the same pricing per PVU this would cost around £77K **resulting in a net saving of over £1.1M.**
